SPECIAL MEETING

Tuesday, 12 October 2021

- 1. **Assembly Special Meeting:** By videoconference on Tuesday, 12 October 2021, commencing at 10.30 a.m. (AEST), the General Assembly of the Presbyterian Church of Australia convened for a special meeting in accordance with the requirements of Article 1.8 of the Articles of Agreement.
- 2. **Constitute:** The Assembly was constituted with the reading of Scripture and prayer, the Moderator, Rev. Dr P.E. Barnes, presiding.
- 3. **Roll of Assembly:** The Clerk laid on the table the roll of Assembly being commissioners to the 2019 General Assembly of Australia with additions and deletions as notified by presbyteries and assemblies. The Assembly resolved that the list of commissioners as made up be the roll of this Assembly.
- 4. **Apologies:** Apologies for absence were received from the Rev. Dr C.R. Thomas (former Moderator-General); Rev. Dr A.M. Bain, Rev. J. Ang, J. Ellis, J. Norved, and J. Otten (ministers); Drs J. Pratt and M. Smith, Messrs R. Bannister, T. Fleming, W. MacRae, and J. Parry (elders).
- 5. **Circular calling this meeting:** The Clerk tabled a copy of the emails convening this special meeting of the Assembly which had been sent to all members of the Assembly on 26 and 27 August 2021 as follows:

Requisition for a Special Meeting of the General Assembly of Australia

25 August 2021

The pandemic caused by the emergence of the novel coronavirus in 2019 has had a substantial effect on the Christian church. As vaccines become more available, churches across the world are discussing the possibility of excluding unvaccinated people from their services of worship and other activities. This issue has the potential to be extremely divisive and deserves consideration at the highest level of our denomination in order that we might seek the mind of God on the matter and move forward in unity.

Flowing from Paul's injunction in Romans 14:22-15:4, this complex issue involves the application of our understanding of doctrine, worship, and discipline – in all of which the authority of the General Assembly of Australia (GAA) is supreme. It is also impacted by our understanding of the inter-relationship of the Church and the Civil Magistrate (WCF XXIII).

Therefore, in accordance with Article 1.8 of the Articles of Agreement, the undersigned members of the 2019 GAA request that you convene a special meeting of the GAA to be held by videoconference on a date and at a time to be determined by you.

- 6. **Approval of Meeting:** The Clerk moved that the Assembly approve the action of the requisitionists in requesting, and the Moderator in convening, this meeting. The motion was seconded. (Min. 10)
- 7. **Point of Order:** Rev. D. Carroll asked the Moderator to rule on the competence of this meeting as being within the jurisdiction of the General Assembly of Australia in accordance with S2.1 of the Articles of Agreement.

The Moderator ruled that the requisition before the Assembly came within the jurisdiction of the General Assembly of Australia in accordance with both the Articles of Agreement and the Assembly's co-ordinate authority.

8. **Question of Privilege:** Rev. D. Brown and K. Murray raised questions of privilege concerning the use of the Remote Interactive Technology in a manner which did not erode the privileges of Assembly members.

The Moderator upheld the questions of privilege.

- Dr R.I. Yager provided guidance on the use of the Assembly website, whereupon the Moderator announced that the procedures outlined by Dr Yager would be followed and the Assembly's privileges would thus receive adequate protection.
- 9. **Point of Order:** Mr R. Holvast asked the Moderator to rule whether it was competent for Remote Interactive Technology to be used before the Assembly approved such use pursuant to the motion proposed by the Business Committee.

The Moderator ruled that such usage was competent.

- 10. **Meeting approved:** The motion to approve the action of the requisitionists and Moderator (Min. 6) was approved.
- 11. **Question of Privilege:** The Rev. M. Powell raised a question of privilege claiming that the circulation of certain documents may have caused some members of the Assembly to misconstrue the intention of the overturists or the overture that had been addressed to this Assembly. (cf. Min. 16).

The Moderator opined that Mr Powell's question of privilege might be relevant in a particular state assembly but it was moot as far as this Assembly is concerned. He then reminded all members of the Assembly that the overture should be considered on its own merits and not according to any preconception.

- 12. **Prayer:** The Moderator led the Assembly in prayer.
- 13. **Communication 1: Resignation of the Rev. Peter Barson as Business Convener** Communication 1 from the Rev. P.J. Barson was laid on the table. Pursuant to notice the Rev. B.M. Meller moved:

That the Assembly:

- (1) With immediate effect, receive Communication 1 being a letter of resignation of the Rev. P.J. Barson from the position of Business Convener.
- (2) Record, with thankfulness to God, the diligence, poise and steady calm with which the Rev. P.J. Barson applied himself to the work of the Business Convener over a continuous period of 27 years from 1994-2021; and thank him for the winsome way in which he brought wisdom, clarity and focus to the work of the Assembly, particularly in pursuit of the health and well-being of the Church, that it might bear fruit in church revitalisation and church planting.
- (3) Record its thankfulness to God for the support provided by Mrs Joy Barson both to Peter in his service as the Business Convener and also to the Assembly Officers generally in hospitality and encouragement.
 - The motion was seconded and approved unanimously.
 - By leave of the house, Rev. B.M. Meller moved clause (4) in an amended form as follows:
- (4) With immediate effect, appoint the Rev. Dr J.P. Wilson to act as the Business Convener until 31 March 2023, and direct that a ballot for the position of Business Convener beyond that date shall be conducted during the ordinary meeting of the Assembly in September 2022.

The motion was seconded and approved.

14. **Business Committee:** The Rev. Dr J.P. Wilson presented the report of the Business Committee concerning the business of this meeting of the Assembly.

The report was received.

The Rev. Dr J.P. Wilson submitted the deliverance.

The deliverance as a whole was approved as follows:

That the Assembly, with immediate effect:

- (1) Invoke the Nobile Officium, in accordance with the powers of the General Assembly of Australia set out in Chapter 7 of the Constitution, Procedure and Practice of the Presbyterian Church of Australia, to adopt a process for the use of remote technology to consider, and to make resolutions arising from, a requisition for a Special Meeting of the General Assembly of Australia from not fewer than thirty members who are drawn from not less than four states in accordance with Article 1.8 of the Articles of Agreement.
- (2) Adopt the use of the General Assembly of Australia October 2021 website for the provision of access to the documentation for the Assembly, and as the method by which members of the Assembly may exercise the privileges accorded to them under the Standing Orders.
- (3) Suspend for the duration of this meeting of the Assembly so much of the Standing Orders as is necessary to allow for voting to occur by electronic means in real-time.
- (4) Approve the following arrangements for this meeting:
 - (a) Sederunt 1: 10.30 a.m. to 12:30 p.m.; Sederunt 2: 1.15 p.m. to finish no later than 5.00 p.m. (AEST)
 - (b) Refreshment breaks of up to 15' may be called by the Moderator at his discretion.
 - (c) Speeches shall be limited in time as follows:
 - Conveners of committees when speaking to the report
 Overturists (per overture)
 - All other speeches
 The time for any speech may be extended by resolution of the House.
 - Subject to extension by resolution of the House, the total time for questions during the presentation of each report or overture
 - Notices of motion should be sent to the Business Convener in duplicate if submitted in hard copy. Submission of a single copy by email is preferred.
- (5) Confirm the following order of business:
 - (a) Constitute meeting
 - (b) Confirm Roll of Assembly
 - (c) Apologies
 - (d) Approve Moderator's action
 - (e) Communication 1: Resignation of Rev. P.J. Barson as Business Convener
 - (f) Business Committee (arrangements for this meeting)
 - (g) Communication 2: Explanatory paper from overturists anent vaccination certificates and worship
 - (h) Overture 1: From seven members of the Assembly concerning vaccine certificates and worship
 - (i) Church and Nation Committee report: Vaccination passports
 - (i) Substantive motions
 - (k) Close meeting
- (6) Note the declaration that has been made repeatedly by the Assembly (e.g. at GAA GB 1994 Min. 17(14) and 2004 Min 102(12)) as follows: "Declare that the Assembly should not receive, as a communication, a document which could be submitted in another form but may receive as a communication.
 - (a) the resignation of an Assembly Officer;
 - (b) any other communication which has been approved by the Business Committee.
- 15. **Communication 2: Explanation of Overture 1** Communication 2, submitted with Overture1 and in explanation thereof was laid on the table. Pursuant to notice the Rev. B.M. Meller moved: That the Assembly:

The motion was seconded and approved.

16. Overture 1 - From seven members of the Assembly concerning vaccine certificates and worship

Overture 1, from seven members of the Assembly concerning vaccine certificates and worship, was laid on the table and received.

There appeared for the overturists, the Rev. M. Powell and D. Middleton.

The overture was stated.

Questions were asked of the overturists.

The debate was adjourned (Min. 19).

17. **Adjournment:** The Assembly adjourned to meet at 1.20 p.m. (AEST) and the sederunt was closed with prayer.

18. **Assembly Constituted:** By videoconference on Tuesday, 12 October 2021 at 1.20 p.m. (AEDT) the assembly met, pursuant to adjournment and was constituted with prayer, the Moderator presiding.

19. Overture 1 – concerning vaccine certificates and worship - resumed

The Assembly resumed consideration of Overture 1, from seven members of the Assembly concerning vaccine certificates and worship (Min. 16).

Further questions were asked of the overturists.

Pursuant to notice the Rev. M. Powell moved:

That the Assembly:

Sustain the Overture.

The motion was seconded and approved.

The debate was adjourned (Min. 22).

20. **Approval of Clerk's action:** Pursuant to notice the Rev. B.M. Meller moved:

That the Assembly:

Approve the Clerk's action in providing a copy of Overture 1 and Communication 2 to the Church and Nation Committee in order that it might prepare a report for the Assembly.

The motion was seconded and approved.

21. **Church and Nation Committee:** The Rev. Dr J. McClean presented the report of the Church and Nation Committee concerning vaccine certificates and admission to services of corporate worship.

Questions were asked of the Convener.

The report was received.

22. Overture 1 – concerning vaccine certificates and worship - resumed

Debate on Overture 1 from seven members of the Assembly concerning vaccine certificates and worship, was resumed (Min. 19).

Pursuant to notice the Rev. M. Powell moved:

That the Assembly:

(1) Exhort all members and ministers to work hard at maintaining the unity of the Spirit in the bond of peace, treating issues of vaccination as a matter of liberty of conscience not determined by church law (Rom. 14:22, 15:4; WCF chapter 20).

The motion was seconded and approved.

Pursuant to notice the Rev. M. Powell moved:

That the Assembly:

Declare that in light of the Bible's teaching on the free offer of the gospel and the unity of the Church, that no Presbyterian Church should deny entry to unvaccinated people for the public worship of God (Matt. 28:19-20; Gal.3:28; Jas.2:1-3; John 17:21-23).

The motion was seconded.

The Rev. A. Vines moved:

That the Assembly:

Amend the motion by deleting all words after "that the Assembly" and inserting the following words in their place:

"Affirm that in light of the Bible's teaching on the free offer of the gospel and the unity of the Church, the Presbyterian Church of Australia does not desire anyone to be denied entry for the public worship of God on the grounds of their vaccination status."

The Moderator ruled that the amendment arose during the course of the debate and did not alter the substance of the motion.

The Rev. D. Brown challenged the Moderator's ruling.

The Moderator's ruling was upheld.

The amendment of the Rev. A. Vines was seconded.

Mr W. Richards moved:

That the Assembly:

Amend the amendment by replacing the word "desire" with the words "intend for".

The Moderator ruled that Mr Richards' amendment arose during the course of the debate and did not alter the substance of Mr Vines' amendment.

The amendment to the amendment was seconded and disapproved.

The amendment of the Rev. A. Vines was put to the vote and approved.

The amended motion was approved as follows:

(2) Affirm that in light of the Bible's teaching on the free offer of the gospel and the unity of the Church, the Presbyterian Church of Australia does not desire anyone to be denied entry for the public worship of God on the grounds of their vaccination status.

The following members recorded their dissent: Rev. M. Crabb, S. Donnellan, C. Garrett, G. Kettniss and G. Munro.

Reasons were given as follows:

"Neither the overture nor the motion make clear the point which the overturists assured the assembly, that this matter has no practical force in sessions as it needs to proceed to state assemblies for consideration. This omission will likely lead to unhelpful misunderstanding in sessions." (S. Donnellan)

"Respectfully, I believe that expressing a desire in regards to something is largely meaningless because it does not necessarily lead to supportive action." (M. Crabb)

Pursuant to notice the Rev. M. Powell moved:

That the Assembly:

Remind all leaders and members of our churches of their obligation to love their neighbours and therefore, voluntarily and willingly, to use all reasonable methods of preventing the spread of disease, including self-isolating for the appropriate period if they show any symptoms of an infectious disease or have a positive COVID-19 test result even if asymptomatic.

The motion was seconded.

Mr C. Morrow challenged the competence of the motion.

The Moderator declared the motion to be competent.

Mr C. Morrow moved dissent from the Moderator's ruling.

The Moderator's ruling was upheld.

The previous question was moved, seconded and disapproved.

Rev. D. Brown moved, as an amendment without notice, that the word "disease", where first appearing, be deleted and the expression "COVID-19" inserted in its place and the words "of an infectious disease" be deleted.

The Moderator ruled that the amendment arose in the course of the debate and did not affect the substance of the motion.

The Rev. P.W. Phillips moved dissent from the Moderator's ruling that the amendment did not affect the substance of the motion.

The Moderator's ruling was upheld.

Mr C. Morrow moved the previous question.

The previous question was seconded and disapproved.

The amendment of the Rev. D. Brown was seconded and disapproved.

Rev. D. Carroll moved, as an amendment without notice, that the words from and following "including" be deleted and be replaced with the following: "including but not limited to: getting a COVID test and self-isolating for the period determined by State Chief Health Officers if a person show any symptoms of an infectious disease, self-isolating for the period determined by State Chief Health Officers when a positive COVID-19 result is received even if asymptomatic, and being vaccinated if physically able to."

The Moderator ruled that the amendment arose in the course of the debate and did not affect the substance of the motion.

The Rev. P. Harris moved the previous question in relation to Mr Carroll's amendment.

The previous question was seconded and disapproved.

The Rev. P.W. Phillips challenged the Moderator's ruling that Mr Carroll's amendment did not affect the substance of Mr Powell's motion.

The Moderator agreed with Mr Phillips.

The Rev. K. Maxwell moved the previous question in relation to the whole motion before the Assembly.

The previous question was seconded and approved, and the Assembly departed from the motion.

23. **Communications with state assemblies and presbyteries:** Pursuant to notice the Rev. B.M. Meller moved:

That the Assembly:

- (1) Request the Clerk to distribute to each State Assembly and Presbytery, the Overture, the report of the Church and Nation Committee, and the consequent resolutions.
- (2) Request that each presbytery clerk further distribute that material to each session within the bounds of the presbytery.
- (3) Authorise the Clerk, at his discretion and upon request, to provide a copy of the Overture, the report of the Church and Nation Committee, and the consequent resolutions to any minister or elder of the Church, with any necessary costs of printing and postage to be at their expense.

The motion was seconded and approved.

24. **Commission to review and approve minutes:** Pursuant to notice, the Rev. B.M. Meller moved:

That the Assembly appoint a commission consisting of the Moderator, Clerk, Deputy Clerk, Business Convener, Rev. J. Irvin, S. Bonnington and G. Ware to review, correct and confirm the minutes of this meeting.

The motion was seconded and approved.

25. **Expression of Thanks:** Pursuant to notice, the Rev. L.J.F. Hall moved: That the Assembly:

(1) Thank the Moderator for convening and conducting this meeting, the Clerk, Deputy Clerk and Business Convener for their contributions to its smooth operation, and Dr R.I. Yager for his

- invaluable assistance in establishing, maintaining and operating the digital interface that made this meeting possible.
- (2) Resume Standing Orders.
- (3) Adjourn to meet for ordinary business at 7.00 p.m. on Monday, 5 September 2022, in the Hurstville Presbyterian Church, corner Park Road and MacMahon Street, Hurstville or at such other date, time and place as may be decided by the Business Committee pursuant to GAA GB 2019, Min. 96.

The motion was seconded and approved.

26. **Closure** The Business of this meeting being concluded, the Moderator thanked the members of the Assembly for their faithful attention to duty, declared that the Assembly stood adjourned to meet again for ordinary business in Sydney on 5 September 2022 and closed the meeting with prayer.
